## WEST MEMORIAL MUNICIPAL UTILITY DISTRICT ORDER LEVYING AD VALOREM TAXES FOR 2021

WHEREAS, WEST MEMORIAL MUNICIPAL UTILITY DISTRICT, hereafter "the District" is a duly organized political subdivision of the State of Texas operating under the authority of Article XVI, Section 59, Texas Constitution, and Chapters 49 and 54, Texas Water Code; and

WHEREAS, Section 54.601, Texas Water Code, requires the District to levy an ad valorem tax on all taxable property within the District in sufficient amount to pay the interest on the District's bonds as it becomes due and to create a sinking fund for the payment of the principual of the bonds when due or the redemption price at any earlier required redemption date and to pay the expenses of assessing and collecting the taxes; and

WHEREAS, at an election held August 11, 2001, the District was authorized to levy and collect a maintenance tax not to exceed \$0.30 per \$100.00 of assessed valuation; and

WHEREAS, the District's Board of Directors has determined that it has tax secured bonds outstanding and should now levy a tax of \$0.17 per \$100.00 valuation for debt service to meet the requirements of Section 54.601, Texas Water Code, for 2021, and that it should also now levy a maintenance tax of \$0.22 per \$100.00 valuation for 2021, for a total 2021 tax rate of \$0.39 per \$100.00 valuation; and

WHEREAS, Notice of the proposed tax rate has been published as required by law.

NOW THEREFORE, BE IR ORDERED BY THE BOARD OF DIRECTORS OF WEST MEMORIAL MUNICIPAL UTILITY DISTRICT, THAT:

- An ad valorem tax rate as set forth above is hereby levied on all taxable property within
  the District for the year 2021 as described above. The District tax assessor/collector is
  hereby directed to issue the required tax notices and proceed with the collection of the
  tax.
- 2. The Board officially finds, determines and declares that this Order was adopted at a duly called regular meeting of the Board and that a sufficient written notice of the date, hour, place and subject of this meeting was posted at a place readily accessible and convenient to the public within the District for the time required by law preceding this meeting, as required by Chapter 551, Texas Government Code, and Chapters 49 and 54, Texas Water Code and that this meeting has been open to the public as required by law at all times during which this Order and the subject matter hereof has been discussed, considered and acted upon.
