

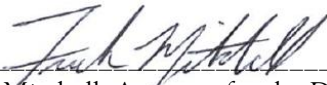
WEST MEMORIAL MUNICIPAL UTILITY DISTRICT
NOTICE OF MEETING AND AGENDA

Notice is hereby given to all interested members of the public that the Board of Directors ("Board") of West Memorial Municipal Utility District will meet in special session, open to the public, at **7:00 p.m. on Monday, August 25, 2025, at the West Memorial Municipal Utility District Sewage Treatment Plant, 22025 Kingsland Blvd., Katy, Texas**, a designated meeting place inside the District. At such meeting the following matters will be discussed and acted upon, as appropriate:

1. Public Comments;
2. Review and approve prior meeting minutes;
3. Review and approve prior STP meeting minutes;
4. Communications Report, including review of website, community outreach, and public relations matters;
5. Discussion related to park improvements, including authorization of any action as necessary;
6. American Legion Post 164 update, including authorizing repairs/improvements as necessary;
7. Tax Assessor Collector's Report, including:
 - a. Delinquent Tax Collections Update, including status of delinquent taxes, collection/uncollectible accounts; termination of water service, installment agreements, foreclosure proceedings, and proofs of claim(s);
8. Receive Financial Advisor Tax Rate Recommendation, including:
 - a. Authorize publication of Public Hearing for Tax Rate Setting;
 - b. Adopt Resolution Declaring Development Status of District (*Developed*);
9. Bookkeeper's Report, including payment of bills, review of investments, and authorize amendments to budget, if necessary;
10. Operator's Report, including review and discuss operating expenses and consider authorizing action or repairs as recommended by the Operator;
 - a. Adoption of proposed rate order amendments and publication if necessary;
 - b. Approve bids regarding installation of security devices at STP;
11. Engineer's Report, including:
 - a. Update on walkway failure at STP, including bids for repairs and TCEQ notification;
 - b. Wastewater Treatment Plant repairs and improvements;
 - c. Water Well No. 2 TCEQ Compliance Updates;
 - d. Update on CIP plan;
12. Attorney's Report;
 - a. Update on property lease/sale with Cabo Bobs;
 - b. Update on revised JSTP Agreement;
13. Discuss pending business and matters for future agendas, including next meeting date;
14. *Executive Session pursuant to Texas Government Code, Section 551.071, et. seq.;
15. Reconvene in open session and authorize any action resulting from executive session;
16. Adjournment.
