RESOLUTION CONCERNING EXEMPTIONS FROM TAXATION

WHEREAS, the laws of the State of Texas provide, under certain circumstances, for the exemption of a portion of the value of residence homesteads from ad valorem taxation; and

WHEREAS, the Board of Directors (the "Board") of West Memorial Municipal Utility District (the "District") has considered the various exemptions which may be granted. NOW THEREFORE,

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF WEST MEMORIAL MUNICIPAL UTILITY DISTRICT THAT:

Section 1. For the tax year 2023, the Board hereby exempts from ad valorem taxation by the District Forty Thousand Dollars (\$40,000) of the appraised value of residence homesteads of individuals who are under a disability for purposes of payment of disability insurance benefits under Federal Old-Age, Survivors, and Disability Insurance or are sixty-five (65) years of age or older, as authorized by, and in accordance with the provisions of, Article 8, Section 1-b (b), Texas Constitution, as amended, and Section 11.13 of the Tax Code, as amended. No person may claim both exemptions, but a person qualifying for both may choose either.

Section 2. For the tax year 2023, the Board has considered and hereby adopts a general residence homestead exemption as authorized by Article 8, Section 1-b (e), Texas Constitution, as amended, and Section 11.13 of the Tax Code, as amended. Twenty percent (20%) of the appraised value of residence homesteads shall be exempt from ad valorem taxation in accordance with the provisions of such laws; provided, however, that no such exemption shall be less than Five Thousand Dollars (\$5,000). A person claiming an exemption under Section 1 above may also claim a general residence homestead exemption.

<u>Section 3</u>. This Resolution constitutes official action by the Board of Directors of the District concerning the foregoing tax exemptions.
